Medical Comments: While working on a lathe, attempting to break off metal chip, employee cut left fifth (little) finger on the metal chip. The laceration was sutured, and employee was given prescription for antibiotic medication.

ESH Comments: The employee was turning a 1-inch square copper bar in the lathe in the IB-2A Tech Shop. A ball of curled copper chips from the activity was building up ahead of the tool and needed to be removed. The employee used a pair of needle nose pliers in his left hand to remove the chips out of the way. He reached with the pliers to pull the ball away from the bar and as he pulled it away a piece from the chips sliced his little finger on his left hand. The individual immediately stopped his work and grabbed a towel to wrap his finger. He then reported to his supervisor and was taken to Medical where he received 5 stitches and a prescription for antibiotics. Work restrictions do not limit the employee's activities and so it is not considered a DART case.
