Medical Comments: While working in switch yard tunnels, the employee developed a rash on the right wrist. The site was cleaned and a dry dressing applied.

ES&H Comments: The employee was working in the Switchyard Tunnels (C, D, and E) to repair a telephone line what was not working due to dampness. In the process of troubleshooting and opening up carious phone boxes, the employee's arms/wrists made contact against the surface of cable trays that were very dirty. The following morning the employee noticed a slight rash on his right wrist and reported to the Fermilab Medical Office and was treated for contact dermatitis (topical dressing applied; First-aid). At the time of the activity the employee was wearing a short sleeved shirt. In the future, the employee will keep a long-sleeved shirt in the workplace to wear to minimize skin contact with surfaces in the tunnel.
