**Medical Comments:** Subcontract employee struck his thumb with a hammer.

**ES&H Comments:** Individual was removing a section of field tile for inspection. The removal requires a portion of the tile to be broken. The individual was using a hammer and chisel to complete the task. He proceeded to miss the chisel and strike his thumb causing the injury. The individual was wearing gloves at the time of the injury. The contractor is looking at a chisel with a guard to prevent this from happening again in the future. This case is not reportable since the contractor had less than 10 employees on site for the project.

**ES&H Comments:** No PPE was worn during the job, but was not required by the sub-contractor. The incident investigation form states that the individual did not violate any safety rules for the task at hand. Fermilab will work with the subcontractor to determine if modified work practices, different tools, or PPE may be appropriate for cable stripping / termination work. This injury is not reportable due to less than ten employees on site.

**Medical Comments:** While moving concrete blocks, the employee felt back pain.

**ES&H Comments:** The employee was working at the Shield Block Storage Building on 01/17/2013 when the incident occurred. The employee was transferring concrete blocks from deteriorating pallets onto new pallets. The blocks varied in weight from 20 to 80 pounds. At approximately 5 pm, he was lifting the final block to be moved that day and twisting to place it on the new pallet when felt a pain in his left lower back. The work was over for the day at that point, so he went home for the evening. The following day, 01/18/2013, he went to the onsite Medical Office where he reported the incident. The symptoms had resolved and no treatment was necessary. The employee returned to work without restrictions
