Medical Comments: Had finished shearing material, walked around racks and struck right shoulder on stock rack. Employee saw an orthopedic and was given 1 physical therapy treatment with exercises.

ESH Comments: The employee was using the power shear in the Lab 1 Cut Shop. He walked around to the back of the shear to retrieve his material, and as he stepped backward to walk around the shear, he bumped into a stock material rack in close proximity to the shear. He hit the corner of the rack, which has rounded corners, with his right shoulder. He did not have any pain, but went to Medical as a precaution. Physical examination showed no marks on the employee's shoulder, and he was returned to work with no limitations. The following day the employee had some range of motion limitations, and was sent out to an orthopedic specialist by Medical. A bruised muscle was diagnosed. The specialist gave the the employee a physical therapy home program, which included providing various Thera-Bands to the employee as part of the program. As a result of these actions,

the case is reportable since this physical therapy program is considered medical treatment.
