


**Medical Comments:** Employee was operating a Crown lift and moving it into position to lift a pump when his left hand which was on the side of the Crown lift was jammed into a cabinet while in motion. Had a small amount of pain but noticed after lunch that the finger was black and blue and swollen. Reported to medical. Was sent out for x-rays. X-ray results were negative for fracture.

**ESH Comments:** The employee was moving a self-propelled material lift (manufactured by Crown Equipment Corp.) into position so that he could use it to remove a water pump from a klystron water skid cabinet in the Linac Gallery. He had his hands on the control handles as he walked behind the lift, but the fingers of his left hand were outside of the outer guard of the handle. As he attempted to turn and maneuver the lift between the cabinets in the area, the 4th finger of his left hand was caught between the handle guard and the cabinet that he was moving past. He had a small amount of pain initially, but noticed after lunch that the finger was discolored and swollen. He reported to the Medical Office where he was evaluated and treated. Treatment included a rigid splint for the finger, making the case recordable. He was sent out for x-rays, which were negative for any fractures. He was returned to work with limitations which do not prevent him from performing his routine job functions.

**Medical Comments:** Employee reported to medical on 9/29/14. While performing job assessment and measurements in lab 1 including ceiling spaces employee notice a insect bite on his left hand. Over the weekend he had increased redness and itching.

**ESH Comments:** The employee, the TD electrical coordinator, was performing an assessment of Lab 2 as part of an investigation into repurposing the building. The assessment included an inspection above the ceiling tiles. The employee noted nothing in particular at the time, but the next day (Saturday) he noticed redness that itched. He talked to the TD SSO Monday morning, who sent him to Medical since it looked like the bite area had been scratched open. The employee subsequently received first aid and was returned to work without limitations.
