Medical Comments: While talking to coworker felt something in my right eye. Was wearing safety glasses. Sent to Geneva Eye Clinic. Was given RX.

ESH Comments: The employee felt something enter his right eye at about 1pm while he was talking to a co-worker on the MW9 shop floor. No work was occurring in the area around where the employee and his co-worker were standing. A box fan, resting on the floor behind the employee was running, providing a slight breeze in the area. The employee was wearing prescription safety glasses without side shields. The foreign body that entered his eye was causing significant irritation, so the employee asked his co-worker to drive him to the Medical Office. At the Medical Office, the employee's eye was irrigated and examined; an abrasion on the cornea was observed. To ensure all foreign matter had been removed, the employee was sent to Wheaton Eye Clinic for an examination. The doctor there did not see any further evidence of a foreign body and prescribed antibiotic drops for the employee, making the case recordable. He was returned to work with no limitations. Earlier in the day, between 8 and 9 am, the employee had been using a grinder and bandsaw on metal parts. He wore safety glasses and a faceshield mounted to a hardhat during that activity and did not notice any eye irritation during the work. It is not clear that this work in the morning had anything to do with the particle that entered his eye in the afternoon, but it is possible that a particle had become stuck on the employee and somehow fell into his eye while he was talking with the co-worker.

Medical Comments: While replacing a thermal expansion tank on a water heater that was 6 feet off the ground, the employee was using a roll up ladder. knee before it hit the ground. Employee was given first aid.



Medical Comments: Employee was replacing a sump pump when the anchor failed causing the anchor and hook to hit the employee on the left side of the head and left hand. Employee was taken to Rush Copley ER by Fermilab Fire Dept. 6 staples were needed.

ESH Comments: Individual was in the process of setting a new sump pump into the pit when the anchor (Hilti) failed. At the time of the failure the sump pump and electric chain-fall were rigged to the anchor point. The electric chain-fall fell from the ceiling and impacted the individual on his head and left forearm. It appears that the anchor point was never installed correctly and was not inspected prior to use. An HA was written for this

job, however it was not present at the job-site or issued with the work order to perform the work. The HA required the use of a hard hat, and to avoid locating one-self under a suspended load. A full review of the work planning process is currently underway. This case is a DART.
