**Medical Comments:** While attempting to move hose, employee was struck by hose on the right nostril and right posterior lower rib, incurring superficial lacerations. Employee was treated by Fermilab Fire Dept. personnel at the station.

**ESH Comments:** Employee was disconnecting the water hose as part of a Main Injector magnet replacement. Two valves needed to be closed in order to isolate the hose from system pressure before disconnecting the hose; however, the employee overlooked closing the 2nd valve. When the employee disconnected the hose, the pressurized hose whipped, striking him on the nose and torso. First aid treatment only; no limitations. Magnet replacement procedure will be revised to explicitly address water system isolation requirements.
