Medical Comments: While walking in office, employee tripped and fell forward; reached out with left hand to break fall, catching hand on desk. Pain and loss of strength resulted in left wrist and fingers. Rigid splint was applied.

ESH Comments: The employee was walking in his office when his foot caught on the tile floor, causing him to stumble and fall forward. There were no obstructions or floor irregularities. As he fell, he extended his left arm and his left hand contacted the top of his desk, arresting the fall but also resulting in the injury to his left hand/wrist. Medical limitations prevent the employee from performing some of his routine work functions, so the case is DART.
