Medical Comments: While moving cribbing, employee got right index finger caught between truck bed and cribbing, smashing finger and causing a fracture (non-displaced tuft fracture). Antibiotic was prescribed.

ESH Comments: The employee was standing on the ground and placing wood cribbing onto a flat-bed truck. The height of the truck bed is approximately four feet from the ground and the cribbing is approximately four inches by four inches by four feet in length. As the employee released one end of the cribbing with his left hand, his right index finger got caught between truck bed and cribbing, smashing finger. The employee was wearing gloves at the time of the incident. The incident is under review to determine cause(s) and preventative action(s). The incident resulted in fracture (non-displaced tuft fracture) and an antibiotic was prescribed. There were no work restrictions as a result of the incident.
