Five facial sutures were required (upper nose), along with an antibiotic. Three left fingers (#3, 4 & 5) were also treated with first aid.

ESH Comments: Incident occurred as the individual walked north along the driveway between Wilson Hall and Linac. The individual was on site performing work-related tasks, so the case meets the criteria for work-relatedness. The case is recordable due to medical treatment.
