ESH Comments: The employee had spent much of the workday using a vertical belt sander in the West Booster Tower shop area. He had worn safety glasses and a face shield while using the sander. After he had left for the day, he developed pain in his left eye and was able to see that there was a particle in his eye. He reported to the Medical Office the following morning, where the presence of an embedded particle was confirmed. The employee was sent to an off-site medical facility to have the particle removed. The employee returned to work with no limitations. The case is recordable due to medical treatment.

She was transported to Delnor Hospital and instructed to remain off-work for the remainder of the day and also the following day. The ice formed as a result of a known water leak at the User Center. The incident is under investigation using HPI principles.


