Medical Comments: After moving boxes filled with books and office effects, the employee noticed lower back pain. He placed an analgesic patch to the area and after sleeping overnight, the lower back pain disappeared. However, over next day or so, the employee noticed right side, lower rib pain when coughing or bearing down and difficulties moving from a lie to sit and sit to lie position.

ESH Comments: The employee's office was moved from IB-1 to IB-2 and he spent most of Friday (5/13) emptying 20+ boxes of books and binders and placing them on his shelves. The Component Storage Group had moved the boxes from IB-1 to IB-2 for him. The employee had some back pain Friday evening and he applied an "Icy-Hot" patch which seemed to alleviate the discomfort. Over the weekend he began to develop pain along his sides. He had scheduled a vacation day on Monday, so when he came in Tuesday (5/17) he went to Medical. He was diagnosed with muscle strain and told to take over-the-counter pain medication (Ibuprofen). This is therefore a first aid only case. Based on discussions with the employee and the location of the side pain, the employee was likely twisting to some degree as he was moving the boxes of books around his office during the unpacking process. The employee has a sedentary job and is not accustomed to physical activity, which likely contributed to the strain. The employee took the Refresher Back Works training June 2009, and is not due to take it again until June 2012.

Medical Comments: The employee grazed the right dorsal forearm on toolbox or drawer. The result was a small abrasion and some minor bleeding. A Band-Aid was applied.

ESH Comments: The employee was walking down the Transfer Gallery 2nd floor hallway. At one point he had to move over to one side because people were talking in the hallway. As he proceeded down the hallway, he noticed he had a small cut (approx. 1/2") on his right forearm that was bleeding. He did not know exactly what cut him, but presumes it occurred when he moved past the people talking in the hallway and came close to cabinets bordering the hallway. The employee reported to the Medical Office where the cut was cleaned and covered with a bandage. He returned to work with no restrictions.
