<b>Medical Comments:</b> While walking down the stairs holding onto the rail and carrying papers, the employee's left foot slipped and she fell down the stairs (~ half way). The fall resulted in pain in her										

left foot with swelling and contusion on her left elbow.

**ESH Comments:** The employee was descending the Wilson Hall stairs (west) from the second floor to the first floor level. Approx. half-way down the stairs, the employee's left foot slipped when they stepped on the stair and the employee slid for 6-8 steps before coming to rest with left foot/leg bent under the right leg. The employee was sent off-site for x-rays of left foot (negative). The incident resulted in first-aid treatment. The employee was carrying material with left hand and using handrail of stairway with right hand at time of incident.

The ankle fracture in FESS will be categorized as an ORPS. The case is currently under investigation, more details will be forthcoming.


