Medical Comments: While setting down a pipe on a trailer the employee's finger got pinched between the pipe and the trailer. He was wearing gloves.										
ESH Comments: The incident occurred outside of G2 Service Building. The employee was assisting a subcontractor in carrying a steel pipe (8 feet long, 2.5 inch diameter) to a trailer. As they were setting the pipe down in the trailer, the employee's right index finger was pinched between the pipe and the trailer bed, resulting in a contusion of the finger. He reported to the Medical Office where he received first aid treatment and returned to work with no restrictions. The employee was wearing work gloves which reduced the severity of the injury.

	onte Tho i	ndividual was	ESH Comments: The individual was at Site 38 by the HUS Building to perform truck/van clean out. While in the back of the van, the individual began backing out of the rear of the							

van holding material with both arms. He doesn't know if his jacket snagged the door or his foot missed the step (possible both) but he did lose his balance, falling to the asphalt on his right hand. The double doors were not staying propped open and had to use his back to push them open as he exited the cargo area of the van. This case is a DART due to medical restrictions.


